7. Quoted Price:

- g) The tenderer may quote for all the item in the quotation.

9. Validity of quotations:

The quotations shall remain valid for a period not less than 30 days after the deadline fixed for submission of quotations.

10. Evaluations of Quotations: The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which are properly signed, and conform to the terms and conditions and specifications in the following manner,

g) The evaluations will be done including the sales tax. If the tenderer has not included the sales tax in his quotation for the item rate, and has also not indicated the rate of sales tax applicable, the quoted rate will be treated as though it is inclusive of the sales tax and no extra payment for sales tax will be made;

h) The evaluation would be done for the item separately the tenderer who has quoted for a partial quantity of the item would be treated as non-responsive. Purchaser will award the contract for the item separately to the lowest responsive tenderer for the item.

11. Award of contract:

b) The purchaser will award the contract to the tenderer whose quotation has been determined to be substantially responsive and who has offered the lowest price as per Para 5(b).

b) The Purchaser reserves the right at the time of contract award to increase or decrease the quantities of the item indicated in Para 1 above by 25% without any change in the unit price or any other terms and conditions.

i) The Purchaser prior to the expiration of the quotation validity period will notify the tenderer whose quotation is accepted of the award of contract. The terms of the accepted offer shall be incorporated in the purchaser order.

j) Normal commercial warranty/guarantee shall be applicable to the supplied goods.

k) Payment shall be made immediately after the delivery of goods and their acceptance.

l) Notwithstanding the above, the purchaser reserves the right to accept or reject any quotations and to cancel the quotations process and reject all quotations at any time prior to the award of the contract.
