The Principals/Trust/Society are required to be extra cautions while filling online application. The contents should be clearly stated in the respective columns. PMB will not consider any request for modifications/changes subsequent to online uploading.

The admission of students for 2023-24 academic year without obtaining continuation of affiliation will not be considered/approved by the board.

If the application for continuation of affiliation is not received on or before 27.05.2023 it will be presumed that you are not interested to run the course/courses for the academic year 2023-24 & no admission(that is either management or Government quota) from your college/Institutions will be entertained under any circumstances.

Copies of documents need to be uploaded/submitted:

- 1. Bank guarantee of Rs.50,000/- per course in Rs. 100 bond paper.
- 2. Existing course/courses, enhancement of seats if any- sanctioned Government Order as per the current courses/Institutions and sanctioned seats.
- 3. Previous year affiliation certificate.
- 4. Trust/Society registered deed.
- 5. Previous 3 years audit report, audited by the chartered accountant.
- 6. Photos of the building exterior & interior including classrooms.
- 7. Teaching staff list with declaration form.
- 8. Hospital utilization certificates with hospital statistics of previous year.
- 9. Pollution control board certificate.
