Curriculum Changes Recommended by the Syllabus Committee (RS2)

- 1. For the batch of 2017-18 admitted students, the course duration is 3 years + 6 months of internship for SSLC and 2 years + 6 months of internship for PUC/+2.
- 2. The Certificate of the Course is renamed as Diploma-I(Certificate-I), Diploma III(CMLT-III) Diploma III(CMLT-III).
- 3. Diploma in Medical X-Ray Technology(DMXT) is redesignated as Diploma in Medical Imaging Technology (DMIT).
- 4. Carry over system is introduced for the year 2017-18. The candidate should clear all the balance subjects within 6 months of Final year.
- 5. 50% of IA marks and 75% attendance are the eligibility criteria for taking the exam. IA marks has to be submitted twice in the academic year, in the month of February and in the month of June. Best one will be considered for examination.
- 6. Question Paper Bank will be uploaded in the website for reference of QP pattern, new Scheme of Examination (RS2).
- 7. Each question paper will contain Section A and Section B. Each section consists of 50 marks with allocation of marks as follows

4 questions X 5 Marks = 20 Marks

- 10 questions X 3 marks = 30 Marks
- 8. Including both the sections a minimum of 35% is regarded as the passing percentage.
- 9. There is no Re-evaluation / Retotalling as per the syllabus committee recommendations. Each section will be containing separate answer scripts and evaluated by different evaluators. No re-evaluation has similar to the RGUHS evaluation scheme.



Examination centers are neutral centers for Para Medical and RGUHS examination centers. Examination will be held in the month of February and August as per the calendar of events.

- 11. The examination centers will be equipped with Biometric and examination software application with an android mobile phone (Android 4 or higher) for invigilator dairy & coding(Mandatory).
- 12. Results will be declared online within a month from the date of last examination.
- 13. Marks cards will be issued within 15 days from the date of result announcement.
- 14. Course completion certificate will be issued within 15 days after the application.
- 15. Students who have not completed the course within six years will not be allowed to sit for the examination.
- 16. Those who have not completed the course within 6 years are eligible to apply for skill council training certificate through skill council (Chief Ministers Kousalya Yojane). The student has to registered in the skill council website within 6 months.
- 17. No Objection Certificate(NOC), Good standing Certificate, Migration Certificate, Provisional Marks card / Provisional Diploma Certificate will be issued through online (2012 batch onwards).
- 18. Student identity card will be issued by the Board. (compulsorily the student has to wear during the classes and examinations).
- 19. Online admission approval / Registration of candidates.
- 20. Updating the Biometric, Photo captured through webcam and Adhaar number for registration of the student is a must (Biometric equipment specification & webcam equipment specification will be given to the institute shortly).
- 21. Teaching faculty details along with Biometric, Photo captured through webcam and Adhaar number registration is must to all the Institutes. Teacher Identity Number (TIN) will be given to all the registered teachers.
- 22. Practical external examiners are deputed from the authority.



Any institute failing to provide willingness of teachers for appointing as external examiner for practical examination and Theory answer script evaluation is not acceptable and their students results will not be declared. Further, the teachers and the institute will be blacklisted.
